Format/Additional Information

1. Except for events #13, 19 and 20, players must be current USATT members or must join (see membership information on entry portion). Memberships can be purchased at the event.
2. Recreational (#20) is for players who have never been rated. On site registration is permitted for event #20 only.
3. All matches will be 3 of 5 games, except in Open Doubles and elimination rounds in Open Singles which will be 4 of 7.
4. Format will be RR groups of four with top player advancing in all events, except Open Doubles will be single elimination.
5. Unrated players may enter any event **BUT** will not advance from their round robin in events #2 through #12 and #14.
6. Depending on entries, top seeded players in Open singles may be placed directly into the elimination round.
7. All age events cutoffs will be 9/19/09.
8. Any event starting 3:30 or later on Saturday **MAY** carryover final rounds to Sunday.
9. Players may not enter more than one event with the same starting time.
10. Tournament management may modify, combine, or cancel events, limit total entries or total entries by event.
11. All USATT rules will be enforced.
12. Ratings as of 9/1/09 will be used for event eligibility; seeding will be based upon latest available ratings.
13. No refunds after entry deadline.

Employee Team Event (#19)

Teams may consist of 2 to 3 players working (or laid off) for the same employer. Team members maybe rated or unrated players. A team match up will consist of 4 singles and 1 doubles match, played in the sequence of A vs X, B vs Y, Doubles, A vs Y, B vs X. Individual matches will be 3 of 5 games, with games to 11 points. Team that wins 3 of 5 individual matches wins the team match up. The team captain need not name the doubles team until after completion of the first two singles matches, and may then name any two players on the team to play the doubles match.
